### 1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector.

In 2021-22, the Council made payments totalling £ 650 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

## Auditor General's report

### Audit opinion – Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources (value for money).

### Basis for Qualification

#### Annual Governance Statement

In my opinion, the Annual Governance Statement is not consistent with the Council's governance arrangements for the year:

- The Statement does not reflect the deficiencies identified by the Council's internal auditor.
- The Council did not make proper arrangements for approving the accounts and did not meet the statutory deadline of 30 June 2022.
- There is insufficient evidence to demonstrate that the Council made arrangements for the exercise of electors' rights to inspect the accounts as set out in the Public Audit (Wales) Act 2004.
- The Council did not calculate its budget requirement as specified by the Local Government Finance Act 1992 before setting its precept.

### Other matters arising and recommendations

I draw attention to our report entitled Inadequacies in governance and financial management issued to the Council in June 2023. This report sets out our detailed audit findings and makes a series of recommendations for improvement.

There are no further matters that I wish to draw to the Council's attention.
